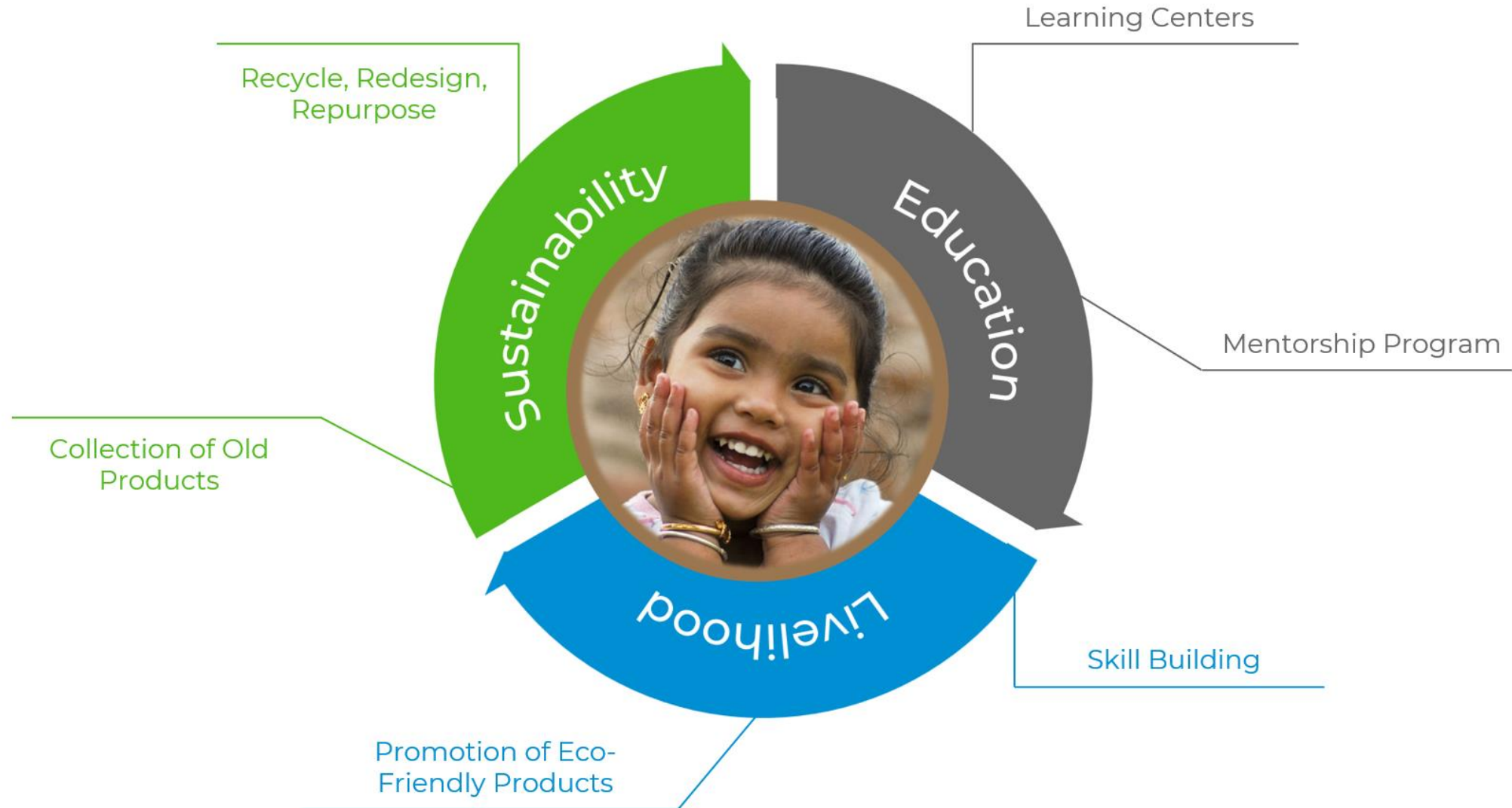

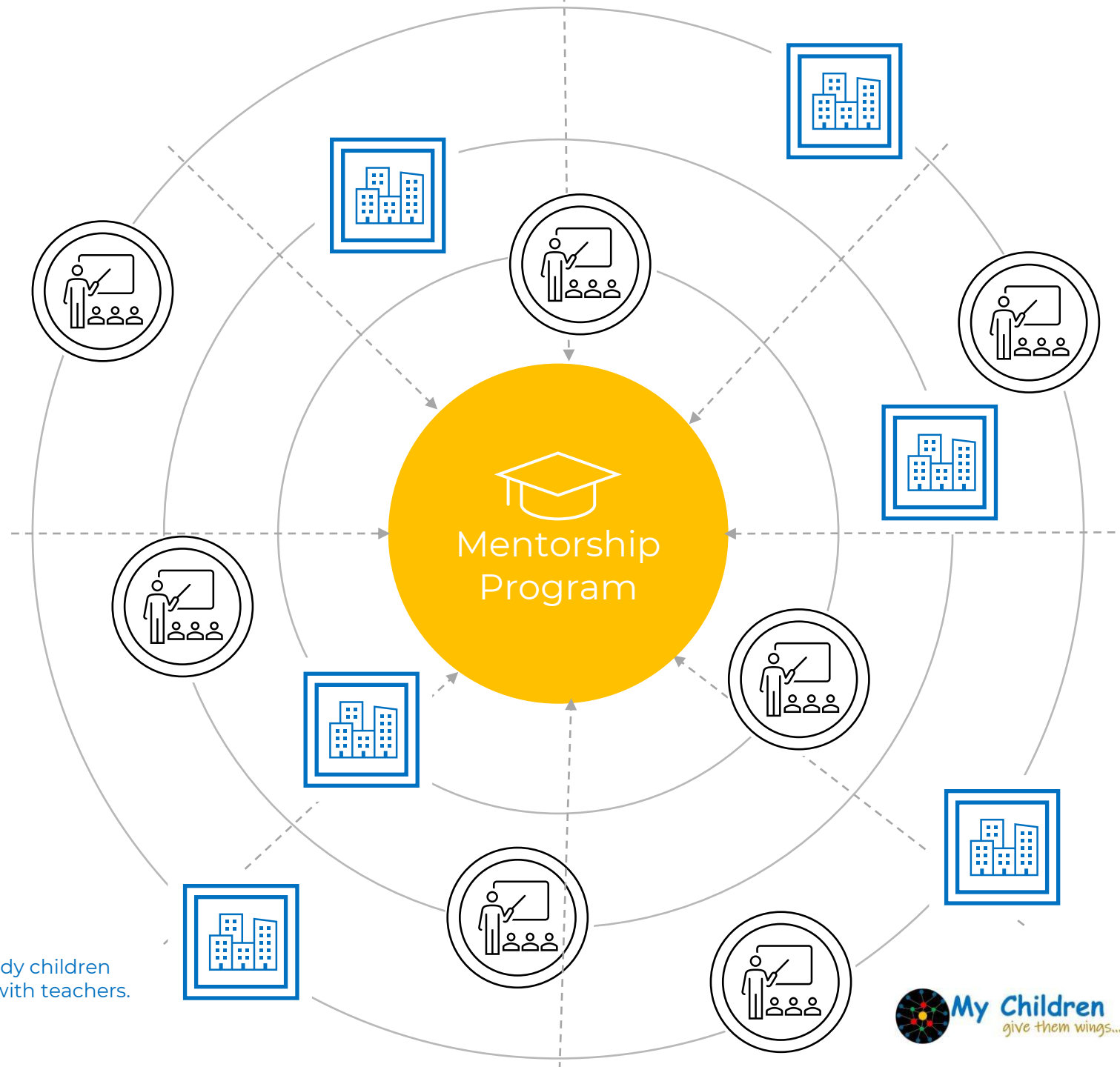
Learning centres for the marginalized children who has less access to quality education.



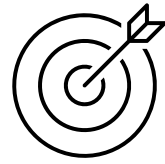

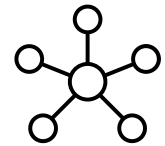


Learning centers project

- Finding children with high potential and bring them to our comprehensive mentorship program so that they can reach their full potential.
- Building local connection to create sustainable ecosystem & livelihood through upskilling, employment, marketing local goods made from clean, organic & sustainable ingredients.



Current Centres (Not Exhaustive)

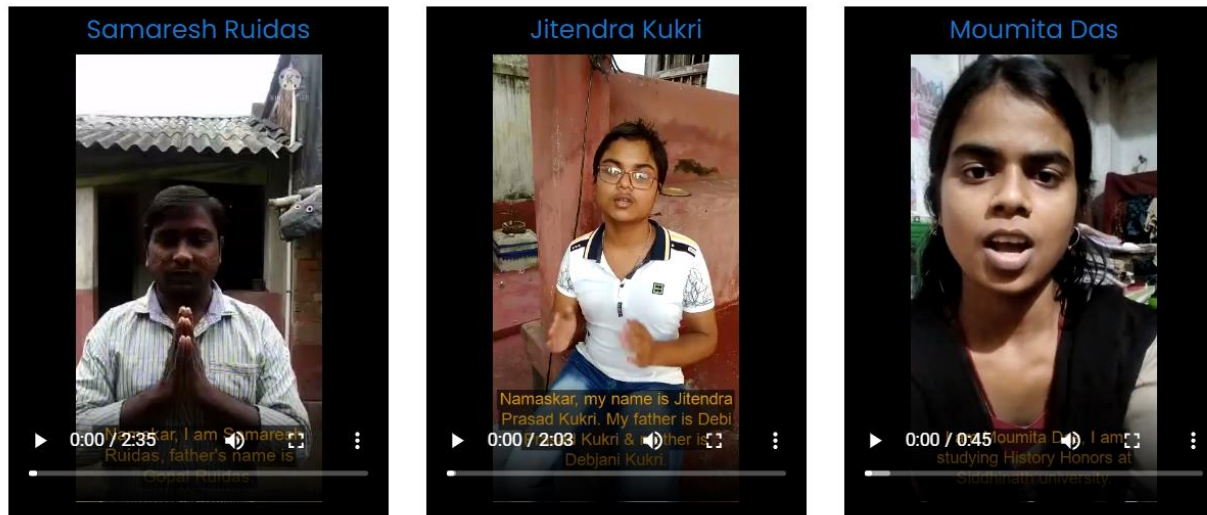
- **Kulti, Asansol:** Established on 29th September, 2022. Children from very low income families like drivers, rickshaw pullers, house maids.
- **Arbetal Village, Bankura:** Established on October 2022, managed by a local graduate student from a very needy family.
- **Goalberia, Purulia:** Established on October 2022, managed by a local needy graduate student.
- **Rangapara, Asansol:** Established on 24th October 2022, 20-25 children from marginalized section, managed by two local teachers.
- **Barathol, Asansol:** Established on 10th September, 2023, Regular tuition of orang children from very low income families of daily wagers. Number of Children is around 31.
- **Paschim Dwarakapur, Patharpratima:** Established on 5th November, 2023. we recruited a housewife who will teach 23-25 children of class 1-4, four days a week.



Mentorship program

Purpose

- To provide comprehensive financial and advisory support to children with high potential in any stream, not only academics.
- To reduce school drop-outs which is still very prevalent, specially for girl children.
- To create a network of people who are willing to support these children from anywhere in the world over an online connected platform.
- To empower a family to become completely independent.
- To create multiplier effect over the time and become self-sustaining i.e. today's supported children will become tomorrow's mentors to other children.



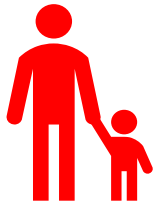
