Kasba, Kolkata - 700042, West Bengal, hereinafter jointly and collectively referred to as “**THE TRUSTEES**”(which expression shall, unless excluded by or repugnant to the subject or context hereof, be deemed to mean and include the Trustee or Trustees for the time being of the Trust hereby constituted and their respective successors or successors-in-office and assigns) of the **OTHER PART.**

AND WHEREAS the Settlor is desirous of creating an endowment or a fund for public charitable purposes in India and for those purposes, she has set apart a sum of Rs.10,000/- (Rupees ten thousand only) being the contribution of the Settlor as per schedule hereunder written:

AND WHEREAS the Settlor desires to make over the said sum of **Rs.10,000/- (Rupees ten thousand only)** to the Trustees to hold the same for Public Charitable Purposes with powers and on the terms and conditions hereinafter declared concerning the same;

AND WHEREAS the Trustees have, at the request of the Settlor, agreed to act as Trustees under theses presents and to hold the said sum of Rs.10,000/- (Rupees ten thousand only) and/or the investments for the time being representing the same or any part thereof and all other sums or properties, which may from time to time form part of the Trust fund, upon the Trust hereinafter declared of, and concerning the same for public charitable purposes;

NOW THIS INDENTURE WITNESSETH as follow:

1. That in order to effectuate the said desire, the Settlor does hereby transfer and assign unto the Trustees the said sum of Rs.10,000/- (**Rupees ten thousand only**) and the investment thereof representing the same and all additions thereto, accretions thereof or the accumulated income there from and all other properties that may be acquired out of the same or may be subject to the Trust and hereafter referred to as the Trust properties, to hold the same in Trust for public charitable objects with the powers and on the terms and conditions hereinafter declared of, and concerning the same.
2. The Trust shall be known as “**MY CHILDREN FOUNDATION**”.
3. The office of the Trust shall be situated at Regent Enclave, Flat No-1A, Block – IV, VIP Road, P.S. – Baguiati, Kaikhali, Kolkata - 700052, West Bengal, which may be shifted from time to time to such other place or places within India as the Trustees may deem fit and proper at their discretion.
4. A. The objects of the Trust shall be the public charitable purposes in India, more fully and particularly described herein below:-
 - (i) To identify talented poor children and provide them adequate financial and operational support to attain their full potential.
 - (ii) By same procedure, it will help to uplift the respective family in more sustainable manner.
 - (iii) Every identified child will be connected to a virtual parent (who is not a legal or biological parent) who will give all possible financial, logistical and morale support to that childlike his/her own child.

- (iv) Trust can also take responsibility of talented children on its own directly as well.
- (v) To give, provide and /or render help and assistance to, and/or implement any scheme for providing livelihood and upliftment of the poor;
- (vi) To give, provide and/or render monetary and/or other help and assistance for the relief of persons affected by natural and other calamities such as flood, fire, cyclone, storm earthquake, accident, pestilence, epidemic, drought, famines, unbearable cost of living and the like to give donations, subscriptions or contributions to institutions, establishments, centres or persons doing relief work on such occasions and calamities;
- (vii) To grant scholarships, prizes and stipends to students belonging to any institution or school or college or universities for pursuing their studies within India without any discrimination as to caste, colour, race, creed or sex;
- (viii) To distribute books, periodicals etc., among poor students for their educational purposes;
- (ix) To grant aid or donation, whether in cash or in kind, to distressed and needy persons for meeting their medical expenses;
- (x) To establish and or maintain orphanage or homes for accommodating and/or helping poor and infirm or handicapped persons;
- (xi) To establish and/or maintain hospitals, ambulance services, charitable dispensaries or like institutions for treatment of sick and/or ailing persons having no means to bear their cost of such treatment.
- (xii) To construct, erect tube wells, wells or any other necessary projects to provide drinking water for the use of the public;

- (xiii) To grant aid, donate or contribute to other trusts or institutions having similar objects;
 - (xiv) To maintain cremation cars for the general public and assist poor for meeting cremation expenses;
 - (xv) Work in the field of rain water harvesting, building sustainable water storage, encourage natural regeneration of vegetation and supplementing with artificial regeneration, maintain and improve the quality of water, raising awareness of water conservation and to contribute in the field of water conservation in all its ramifications.
 - (xvi) To support, conduct and build awareness among individuals as well as to different business enterprises about go Green Initiatives such as reducing of energy use or support the use of alternative environment friendly energy sources, reduce greenhouse gas emissions and global warming and take part in all possible initiatives to minimize the negative environmental impact and keep our planet green and clean.
 - (xvii) To work in the field of environmental study and do all necessary work in all its ramifications to reduce the contamination of the physical and biological components of the earth/atmosphere system
 - (xviii) To purchase or otherwise acquire lands or buildings and erect buildings on any land so purchased for the purpose of locating such institutions and equip such school, college, hospitals or medical colleges with necessary equipment, fixtures and fittings for public charitable purposes;
 - (xix) To do all other acts, matters and things for the use and benefit of the public at large as the Trustees may in their absolute discretion think fit and proper;
4. B. For the purpose of attaining and/or carrying on all or any of the objects specified in Paragraph 4. A. above, the Trustees shall have powers to do the following acts and deeds;

- (i) To accept voluntary donations or contributions in cash or kind from the Settlor, the members of his family or any other persons or concernor institutions on such terms and conditions as the Trustees may in their absolute discretion think fit and proper;

The trustees may accept donations, grants, subscriptions, aids or contributions from any persons, Government, Local Authorities or any other Charitable Institutions, in Cash or in kind including immovable property, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the object of the Trust. While applying such receipts to the objects, the trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.

- (ii) To solicit, obtain, accept, offerings, subscriptions, donations, grants, gifts, devise and bequests from the founder or any other individual, firm, company, L. L. P. (Limited Liability Partnership), trust, society, central government, state government or institutions interested in the objects in the trust to purchase or otherwise acquire lands or buildings and erect buildings on any land so purchased for the purposes of investment of the Trust Funds and to spend and/or utilize the rental or other incomes arising there from for the purposes connected with or conducive to the promotion of the objects of the Trust;

- (iii) To purchase, acquire, hold, manage, improve, develop, exchange, sell, ease, mortgage, charge, dispose of, turn to account or otherwise deal with all kinds of properties movable or immovable, for the purpose connected with or conducive to the promotion of the objects of the Trust;

- (iv) To borrow, lend and/or otherwise deal with the moneys or properties belonging to the Trust and to give security or take security in connection with the said dealings or acts, subject to the provisions of Sec.11(5) of the Income Tax Act, 1961 including any statutory modification thereof that might be made from time to time;

- (v) To construct, alter or keep in repair from time to time building or other immovable property belonging to the Trust;
- (vi) To make, accept, endorse, discount, execute and issue cheques, Promissory Notes, Bills of Exchange and other negotiable or transferable instruments;
- (vii) To invest moneys of the Trust not immediately required for its purpose in such form or mode as prescribed in Sec.11(5) of the Income Tax Act, 1961, since amended, including any amendment that might be made from time to time; and
- (viii) To amalgamate this Trust with any other trust having similar objects or to get other trust having similar objects amalgamated with this Trust with prior sanction of all the Trustees in the meeting and with prior approval of the Commissioner of Income Tax having jurisdiction, for the time being, over the Trust;
- (ix) To sell, mortgage, let out, lease, exchange, gift and otherwise transfer or dispose of or deal with all or any property movable or immovable of the Trust for the furtherance of the objects of the Trust;
- (x) To appoint or make provision for appointment of sub-committee/sub-committees of Trustees and/or others to attend or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the Trustees may prescribe;
- (xi) The Trustees may appoint secretaries, managers, lawyers, solicitors, auditors, architect, engineers, surveyors, agents, gomastas, or any other employees for the purpose of management and supervision of Trust Estate, for collection of rent etc., for keeping the accounts and records and for other purposes of the Trust;
- (xii) The Trustees shall have full power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the trust estates/ trust properties and to adjust and settle all accounts relating thereto and do all other acts and things fully effectually for furtherance of the object of the Trust without being liable for any bonafide loss occasioned thereby;

(xiii) The Trustees shall have full power to initiate and/or defend any legal proceedings for protecting the right, title and/or interest of the Trust Estates/Trust Properties and/or for removing any difficulties or obstructions in the way of achieving the object of the Trust;

(xiv) The Trustees shall have power to frame such Rules, Bye-Laws and Regulations as they think fit with respect to the working of the Trust for fulfilment of the purpose of the Trust and for carrying out the objects of the Trust. Such Power to frame rules shall not anyhow affect the express provision of this Trust Deed;

4. C. Without prejudice to the generality of the aforementioned objects:-

- I. The activities would be of purely public charitable in nature and not motivated for profit and the funds of the Trust, or institution (if created or established) would be utilized only towards the objects and no portion of it would be distributed in any manner to the Trustees or persons defined in Sec.13 (1) (c) of the Income Tax Act, 1961.
- II. The Trust shall be an irrevocable public charitable Trust for the benefit of all persons belonging to whatever community irrespective of caste, creed, or religion, to function as a non-communal Trust and as a secular organisation and the Trustees should possess the said amount of corpus endowed by the Settlor / Author of the Trust and such other properties (both movable and immovable) as may be required from time to time by the Trust, by Purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designated as Trust Properties) on the Trust herein mentioned.
- III. If any of the objects, in whole or in part or any other provision of this declaration is found to be repugnant or inconsistent with any of the provisions of Law, Rules, Regulations, Notification, Ordinance, Circulars, etc., as are applicable on the relevant date, such objects or provisions shall be deemed to be honest to the extent

of such repugnance or inconsistency and if any of the objects of the Trust is found to be invalid on the ground of vagueness or any other reason by the competent authority, it shall be deemed to have not been included in the objects of the Trust so as to effect the validity of the Trust.

IV. Nothing contained in this declaration shall be authorised the Trustees to do any Act which may in any way be constructed as violative or contrary to the provisions of various sections of Income Tax Act, 1961 or any other statutory modification thereof and all activities of the Trust shall be carried on with a view to benefit the public at large without any PROFIT MOTIVE as for public charitable purposes as may be permissible under the provisions of the Income Tax Act, 1961.

5. The number of the Trustees shall be not more than seven and not less than three. But there is no limit for General Membership. Any individual Indian or Foreigners also are eligible to take membership of the Trust. The membership is subject to approval of the Board of Trust.
6. The first Trustees shall be :
 - a) **SHRI DEBASHIS MAJUMDER**
 - b) **SUBHRAJIT BHATTACHARJEE**
 - c) **SUDEB CHAKRABORTY**
 - d) **SUMONA CHOUDHURY NEE BHATTACHARYA**

The Trustees may from time to time open and maintain in the name of the Trust a banking account or accounts with one or more scheduled banks and may operate on the same or authorize any one or more of them from time to time to operate on the same;

7. The objects of the Trust shall be carried out in the Union of India and the income of the Trust fund shall be spend and/ or utilized for the public charitable purposes of the Trust within the Union of India;
8. The Trustees may appoint one from amongst them as the Managing Trustee for such time as they may determine and such Managing Trustee shall continue to act as such until

another Managing Trustee is appointed in his/her place. Subject to general control and supervision of the Trustees, the Managing Trustee shall manage the Trust and its properties and funds and carry on the affairs of the Trust and shall have all necessary powers and authorities for that purpose. The Trustees may at any time co-opt any person or persons as a Trustee or Trustees of the Trust hereby constituted subject to the maximum hereby prescribed;

9. The Trustees named in Clause-6 hereinabove shall be the first Trustees hereof and whenever any Trustee shall die, resign, refuse or become incapable or incompetent of acting or shall permanently leave India, the surviving or continuing Trustee or Trustees may appoint any other competent person or persons to be a new Trustee or new Trustees and on every such appointment, the Funds of the Trust shall be vested in a new Trustee or Trustees together with the surviving or continuing Trustee or Trustees;
10. The Trustees may appoint and nominate one of them as their Chairman for such time as may be determined by the Trustees and such Chairman shall continue to act as such until another Chairman is elected in his/her place. If at any meeting the Chairman is not present, the Trustees present shall choose one of the them to be the Chairman of such meeting;
11. The surviving or continuing Trustees may act notwithstanding any vacancy in their body PROVIDED HOWEVER that if the number of Trustees shall fall below three, the minimum fixed by these presents, the Trustees shall not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum;
12. A resolution in writing circulated amongst all the Trustees and passed by a majority of the Trustees shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened;
13. Notice of the meeting of the Trustees and all communications may be sent to the Trustees at their addresses registered for the time being in the records of the Trust;
14. All meetings of the Trustees shall be held at such place or places as the Trustees for the time being may from time to time decide;

15. The minutes of the proceedings of every meeting of the Trustees shall be recorded in a book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so recorded and signed be conclusive evidence of the operation and other matters transacted at such meeting;
16. Three Trustees shall form a quorum for meeting of the Trustees if the number is more than five, and if five or less than five, two will form quorum. In case of difference of opinion amongst the Trustees in any matter, the opinion of the majority shall prevail and the dissenting Trustees shall be bound to join in the act which may have to be performed by the Trustees in pursuance of such decision; PROVIDED HOWEVER that in case of equality of votes, the Chairman shall have a casting vote;
17. The Trustees shall be entitled to frame and from time to time alter, amend and add to such rules and regulations for the purpose of carrying out the objects of the Trust and for its proper administration as they think fit; PROVIDED HOWEVER that no alteration, amendment or addition to such rules and regulations shall be made except at a meeting at which all the Trustees are present and with the consent of the majority of the Trustees. PROVIDED FURTHER that no alteration or amendment shall be made in contravention of any of the provisions of the Income Tax Act, 1961 or the Rules or Notifications thereunder which might be in force from time to time. Any such amendment shall come into effect after obtaining approval of the Commissioner of Income Tax/ The Director Income Tax (Exemptions) having jurisdiction over the Trust. It is also made explicitly clear that no amendment of the Trust Deed shall be made which may prove to be repugnant to the provisions of sections 2(15), 11, 12, 13 and 80G of the Income Tax Act, 1961 as amended from time to time;
18. Should any of the property belonging to the Trust Fund be acquired by the Government or any other public body or bodies, the Trustees shall be entitled to withdraw the compensation allowed in respect thereof and to invest the compensation money in such manner as they shall think fit, subject to the provisions of the Income Tax Act, 1961.
19. The Trustees shall keep or cause to be kept proper books of account wherein shall be kept an account of the Trust Fund, receipts and disbursements and shall appoint a Chartered

Accountant to be auditor of the Trust Fund and shall have the accounts audited by the said auditor once at least every year. The accounts of the trust shall be closed on the day of 31st March of every English Calendar year.

20. CESSATION :

- a) A Trustee shall be entitled to resign from office by a notice of not less than 30 days from the date of notice. The resignation shall be effective from the 31st day from the date of resignation.
- b) Notwithstanding the above, the Board of Trustees may remove a Trustee from office by an ordinary resolution, if such Trustee:-
 - i) Is found to be of unsound mind by competent medical practitioners,
 - ii) Applies to be adjudged as an insolvent.
 - iii) Is adjudged as an insolvent,
 - iv) Is convicted by a court of law of any offence involving moral turpitude and sentenced in respect thereof for committing such offence,
 - v) Absents himself without sufficient cause from three consecutive meeting of the Board of Trustees or from all meetings for a continuous period of 12 months whichever is longer.
 - vi) If any of the trustee dies;

In any of the aforesaid events if a Trustee become ceased to be a Trustee then the surviving /continuing Trustees shall appoint in his/ her place any other Trustee by consent of the majority of Trustees.

- 21. Any vacancy in the office of the Trustees or the absence of any of the Trustees from town will not invalidate any act done or resolution passed by the remaining Trustees in a meeting provided there is a quorum.
- 22. No Trustee shall be liable for any act or omission of the other or others of them and no Trustee shall be liable for any loss of the Trust properties unless caused by his/her wilful neglect.

23. The Trustee or Trustees of these presents for the time being may reimburse himself/herself or themselves and pay all discharge out of Trust Fund or moneys in their hands all expenses incurred in connection with the execution of the objects of the Trust according to the powers under these presents.
24. The Trustees shall be entitled to execute and give mutual power or powers of attorney, authorizing any other persons or persons to act in all matters connected with the Trust on behalf of the Trustees.
25. The receipts granted by any one of the Trustees for any moneys, stocks, funds, securities or investments paid, delivered or transferred to the Trust in exercise of the powers hereof shall effectually release and discharge the person or persons paying, delivering or transferring the same from the liability.
26. The Trustees may employ any person or persons to do any work connected with the Trust which the trustees may consider necessary or expedient in connection with the management of the Fund or the assets hereof and the necessary expenses of the management and all expenses incurred by the Trustees in or about execution of the object of the Trust, shall be debited to the trust account.
27. Any Conveyance, Mortgage, Re-conveyance, Lease or any other deeds, documents and assurances whatsoever may be signed, executed and registered by any two Trustees or more of the Trustees authorized by a resolution of the Trustees in that behalf and such Conveyance, Mortgage, Re-conveyance, Lease or other deeds, documents and assurances so signed by any two or more of the Trustees shall be deemed to have been signed, executed and registered by or on behalf of all the Trustees for the time being.
28. The trustees may at any time wind up the Fund provided all the Trustees agree to such winding up and in such a case the Trustees shall realize all assets and securities and prepare and/or complete the accounts of the Fund and after payment of all costs and expense of winding up of the Fund, they shall distribute and/or donate Funds and /or assets remaining in their hands among such charitable Institution or Institutions having objects similar to those of this Trust in such proportion as they may think fit and proper,

subject to the limitation or restrictions imposed in this behalf by the Income Tax Act, 1961.

29. The Trustees may delegate any of their powers to one or more Committees or Sub-Committees consisting of such person or persons from amongst themselves as they may think fit and such Committee or Sub-Committee shall function subject to such rules or directions as may be prescribed or given for the purpose by the Trustees from time to time.
30. The Trust is hereby expressly declared to be an irrevocable Trust for public charitable purposes and all the provisions of this Deed are to be construed accordingly.
31. Nothing contained in this Deed shall be deemed to authorize the Trustees to do any act which may in any way be construed as violative of or contrary to the provisions of section 11 and/or 13 of the Income Tax act, 1961.

32. DECLARATION

A. TRUST PROPERTY : IMMOVABLE PROPERTIES OF THE TRUST

✓ No immovable property belongs to the Trust shall be sold, exchanged, transferred, covered, mortgaged or alienated in any manner whatsoever except when such exchange, transfer, conversion or alienation :

Is imperative in the interest of the Trust and Institution and Department connected therewith.

i) Is not likely to adversely affect to any extent whatsoever the existence and benefit of the Trust, Institution and departments connected therewith an object of the Trust, and

Is decided to that effect by the Board in its meeting by a resolution passed by majority of the Trustees present.

At present the trust has no immovable and landed property save and except the Trust Value amounting Rs. 10,000/- in its own name and no immovable and landed property is being settled in favour of this trust by this document.

- B. All aims / objects / purpose of the trust herein stated above shall come into effect / force after necessary appointment of the competent Govt. authority in the case where affiliation / permission / licence / sanction is required,

subject to the limitation or restrictions imposed in this behalf by the Income Tax Act, 1961.

29.
